He said that it is a matter of great pride to have the opportunity of hosting the 5<sup>th</sup> Congress of Federation of Asian-Oceanian Neuroscience Societies (FAONS) alongwith XXVIII annual meeting of Indian Academy of Neurosciences (IAN) at Lucknow and one of our past President Dr. P.K. Seth is currently serving as the President of FAONS. He congratulated and thanked him for his initiatives to hold the Congress at Lucknow. He also made a special mention of Dr. Vinay K. Khanna, Secretary HQ for his untiring efforts to bring the congress to the reality. He further acknowledged Professor P.N. Tandon, Dr. B.N. Dhawan and all the past Presidents of IAN for their guidance and support in making this event memorable being organized for the first time in the country. Following this, the discussion as per agenda followed,

- 1. The minutes of the last EC meeting held at Jaipur on December 17, 2009 were confirmed.
- 2. The recommendation of the Search Committee for the award of Professor B.K. Bachhawat Memorial Life Time Achievement Award for 2011 to Dr (Ms). Devika Nag was considered and approved. The EC further

suggested that the awardee for KT Shetty Memorial Oration be selected based on the nominations received in due course of time.

7. Being away from the country, Dr. Akshay Anand, the Editor of the journal of the Academy, Annals of Neurosciences could not attend the meeting. The discussions on certain points could not be held in his absence and thus following committee was constituted to materialize the issue.

- 9. The venue of the next annual conference of IAN in 2011 at New Delhi to be organized by Dr (Ms). Shashi Bala Singh was approved. She alongwith his colleague Dr. Sunil K. Hota briefed about the facilities and infrastructure available at DIPAS and assured the members to have a good scientific meeting. The EC suggested to organize the meeting in late October or early November to avoid overlap with other conferences and have good participation of neuroscientists from India and outside.
- 10. Based on the nominations received for various posts, the Executive Committee for 2010 2011 was proposed for the approval of the General Body (list enclosed as Annexure I).

Any other matter

- 1. Dr. B.N. Dhawan informed that CINP has asked for proposal to have a satellite meeting in 2012 and thus suggested that it could be held in India. He said as India has many institutions of neuroscience research and strength of basic and clinical neuroscientists, it will be a good opportunity to have the meeting to showcase the research in the area on one hand and develop linkages between the Indian and overseas scientists on the other. The EC appreciated the views of Dr. Dhawan and requested him to explore the possibility.
- 2. Dr. A.K. Agrawal informed that many applications from M.Sc. students have been received to be the Life Member of the Academy. As per the amended rules, an individual has to be Ph.D to apply for the Life Membership else he/she may be the Associate Member. Dr. Agrawal requested the EC to permit the interested M.Sc. students to join as Life Members to motivate them and for being associated with the area of neuroscience. Following committee was formed to look in to the matter so that the issue be resolved in the next EC meeting.
