Indian Academy of Neurosciences Minutes of the Executive Committee Meeting held at All India Institute of Medical Sciences (AIIMS), New Delhi on Monday; November 18, 2019

The meeting of the Executive Committee (EC) of Indian Academy of Neurosciences (IAN) was held in the Seminar Room, Department of Physiology, All India Institute of Medical Sciences (AIIMS), New Delhi. Dr (Ms) Shashi Bala Singh welcomed the members and thanked them for coming over to attend the meeting. She congratulated the organizers for choosing a relevant theme for the conference and developing an effective scientific programme. The meeting proceeded as per the agenda,

- 1. The Secretary HQ informed that the minutes of the last EC meeting held on October 28, 2018 at Banaras Hindu University, Varanasi were circulated after seeking approval of the President. Since no comments were received on it, the minutes were approved by the EC.
- 2. The Secretary HQ informed that approval of EC with respect to the recommendation of the Search Committee that KT Shetty Memorial Oration for the year 2018 be conferred on Dr Aditya Murthy (CNS, Bengaluru) had already been obtained by circulation. - 6. The statement of accounts duly audited by the Chartered Accountant was presented by the Secretary HQ, IAN in the absence of Dr AK Agrawal, Treasurer who could not attend the meeting due to important personal work at the last moment. The EC was informed about the expenditure, savings, induction of new Life and Associate Members during the year. The members approved payment of dues to IBRO and FAONS to continue affiliation of IAN with these academic bodies. The efforts of the Treasurer for maintaining IAN accounts efficiently were appreciated and the report presented was approved by the EC.
- 7. Dr Akshay Anand presented the Editor's report and informed about the new partnership of IAN with SAGE to continue the journal of the Academy Annals of Neuroscience as the contract with KARGER terminated. Fine details about the editorials, original papers, reviews, commentaries and reports received for publication were informed to the members. Dr Anand also informed the details of online submissions during the year 2019 and rolled over articles from previous submissions considered for publication. He said that all the three issues of the journal Annals of Neurosciences for the year 2019 will be brought out soon as per the requirement of indexing agencies including Pubmed. While acknowledging the help of Editorial Board and staff in bringing out the issues on time in a professional manner, he mentioned about the updates and posts on the prominent social networking websites to enhance the visibility of the journal and moreover to attract attention of neuroscience fraternity to submit papers. He further informed the members that the journal is being tracked for Impact Factor through ESCI of Thompson Reuters.

The EC appreciated the efforts of Dr Anand and suggested him to explore the possibility to raise funds through DBT / DST for continuation and sustenance of the journal. A committee with following members was approved to explore the possibility for the purpose,

8. The EC was informed that the proposal to hold the XXXVIII annual conference of IAN in 2020 at UoH, Hyderabad had already been approved by the GB in its meeting held on October 30, 2017 at Ravenshaw University, Cuttack. Dr (Ms) Anita Jagota, the designated Organizing Secretary gave a brief presentation about the venue and discussed the format of the scientific programme. She informed that the dates October

5 – 7 are suitable to hold the IAN meeting in 2020. The EC appreciated her endeavours and suggested to seek help from Dr (Ms) Shashi Bala Singh, the President, IAN who is also the Director at NIPER, Hyderabad. Dr (Ms) Jagota immediately agreed to the suggestions of the members to have a grand international meeting at Hyderabad.

The Secretary HQ also informed about a proposal received from Dr Mehdi Hayat Shahi to hold the IAN meeting at Aligarh Muslim University, Aligarh in 2021. The matter was discussed in details and it was suggested that proposals from other centres should also be invited and the decision on the venue for 2021 be taken later.

- **9.** The Secretary HQ informed about the academic activities undertaken under the auspices of IAN local chapters at Kolkata, Lucknow, Varanasi, Aligarh and Bengaluru. The EC appreciated the efforts of the local chapters and suggested to plan more activities at a regular interval involving young neuroscientists. It was further discussed that activities under the IAN IBRO Global Advocacy programme may be organized by the local chapters. A plan of activities to be undertaken may be submitted to the Secretary HQ by June 30, 2020. The proposals received from local chapters will be reviewed and those found suitable may be partially supported (up to INR 25,000/-) by IAN to meet the expenses.
- **10.** Based on the suggestions for the posts to be filled up, the Executive Committee for 2019 was proposed as mentioned in Annexure I. It was further suggested that proposed EC may be placed before the General Body for approval.

The meeting ended with vote of thanks to the Chair.
